














#### **Register of Members**

Any register or list of members kept by any registered society shall be prima facie evidence of any of the following particular entered therein:

- The date at which the name of any person was entered in such register or listed as a member;
- The date at which any person ceased to be a member.





In order to be qualified for membership of cooperative Society a person, other than a registered Society, must, at the time of application –

- Have attained the age of sixteen years; and
- ♣ Be resident within or in occupation of land within the Society's area of operations as described by the rules:

Provided that a pupil attending any school, may with the consent in writing of the Chief Education Officer, be registered as a member of a Society.

### **Proof of Entries in Books of Society**

A copy of any entry in a book of a registered society regularly kept in the course of business shall, if certified in such manner as may be prescribed by the regulations, be received in any legal proceeding, civil or criminal. As prima facie evidence of the existence of such entry and shall be admitted as matters evidence the transactions and accounts therein recorded in every case where, and to the same extent as, the original entry itself is admissible.
